MINUTES OF MEETING OF THE COMMISSIONERS OF THE WOOD RIVER DRAINAGE AND LEVEE DISTRICT June 6, 2019

The Commissioners of the Wood River Drainage and Levee District held a Meeting on Thursday, June 6, 2019 at the Wood River Drainage and Levee District Office, 543 W. Madison Avenue, Wood River, IL 62095. The meeting was called to order at 1:00pm by Commissioner Carnell a delayed meeting due to Emergency Flood Management.

US Army Corps of Engineers Comments:

1. With all the flood fight activity going on, wanted to ensure that you have visibility on the Biddability, Constructability, Operability, Environmental and Sustainability (BCOES) Review currently underway for Relief Well package #1. A meeting has been set for Tuesday June 18, at 1:00pm. Conference call invite was sent to Vince Milazzo and Catrenia Roach

Wood Engineering Comments:

Since the last meeting on 21 May 2019, Wood has:

• Erosion Repair Project (2019-01)

- o 08FEB19 Plans/calculations submitted to USACE
- o 04MAR19 USACE Review comments received
- 11MAR19 Wood notified that USACE is also going to require a Phase I Cultural Study
- o 11APR19 Wood resubmitted plans/calculations to USACE
- o 04JUN19 Board signature on 404 Application. Will submit to USACE later today.
- o TBD A Phase I Cultural Study is required for "Repair Area #3". This work will be completed as soon as river levels allow.

As previously approved by the board of commissioners, once approval is received from USACE, this project will be advertised for bid.

• Gravity Drains Inspection Project (2019-02)

- Wood continues to develop a procurement package for the CCTV inspection of gravity drains in Upper Wood River, Lower Wood River and the East-West Forks.
- o Design will be complete early summer 2019 with execution this fall.
- o Will be highly depended upon river levels
- **Routine Inspection Deficiency Corrections** USACE to provide the final version of the FY2019 inspection packet to the District prior to assigning responsibilities.
- System-Wide Improvement Framework (SWIF) LOI Wood/WRDLD in receipt of comments from USACE. Wood is reviewing comments and will address those that are applicable once the final version of the FY2019 inspection is received by the District.
- Ongoing Coordination with the District Wood continues to coordinate weekly with Vince Milazzo, his

staff, and the Board of Commissioners regarding routine operations of the district.

- Emergency Repairs at East Alton No. 1 Pump Station; including coordination with USACE
- o Section 408 requests from BP for discussion today.
- o Assisted with coordination of District during Major Flood including many meetings with Madison Co EMA, USACE, local municipalities, and Madison Co board members.
- Ongoing Coordination with the USACE LERRDs (Land, Easements, Rights-Of-Way, Relocation, and Disposal Areas) work continues. Wood continues survey/title work for parcels adjacent to the levee that will require Rights of Entry (ROE), Temporary Construction Easements (TCE), and Permanent Easements (PE) for future Authorized Level projects. Wood has begun coordination with new outside counsel. Will resume LERRDs when standard ROE documents have been approved.

Luken Insurance Agency Comments: No Report. Johansen asked if volunteers were covered under our insurance. Jeff will get specifics and get back to the board.

Minutes of the previous Meeting: The last open meeting on Tuesday May 28, 2019 was a meeting of transition and those minutes will be available per Attorney James Craney for the next meeting scheduled for June 18, 2019. Superintendent/Maintenance Report Milazzo stated the Superintendents report has been presented to be read and will answer any questions. Milazzo and Wood specifically spoke in regards to the Wood River Pump Station Flap Gate Repair and possible cost. Motion was made by Johansen to approve Superintendent Report, seconded by Carnell.
