The Commissioners of the Wood River Drainage and Levee District held a Meeting on Tuesday, Aug 7, 2018 at the Wood River Drainage and Levee District Office, 543 W. Madison Avenue, Wood River, IL 62095. Present were Commissioners Weber, Miller and Carnell. Rene Butler, Attorney; Jeff Luken, Insurance Agent; Steve Adler, Metro East Sanitary District; and Hal Graef, USACE. Hal Graef, US Army Corp of Engineers-

Slide on Canal Road Is complete, just waiting on seeding. Slide close to Hawthorne is underway except for seeding. Completion date is Sept 7, 2018. Spoke with Mark from MCT regarding the repair of bike trail after the slide repair. There is not an agreement between us and MCT or the Wood River Levee District to repair it back to its original state with asphault. It will be replaced with crushed stone. Also, Enbridge has sent in a 408 request for a pipeline crossing, COE has no Problems, just waiting on commissioners review. The Deep Cutoff wall is underway, working on test section. No completion date but estimating end of the year. Contractor has had to revised their schedule due to repairs. The Wood River supplemental report is currently going through 4 levels of review. Complete/Approved report should be completed by late Jan 2019. The Project Partnership Agreement is being revamped. Estimated completion date is December 2018. October 1, 2018 is when the COE's fiscal year begins, the Flood Prevention District and Wood are supplying the specs for Bid Packeage 8, which includes additional relief wells, a new pump station.
