Gravity Drains Inspections (Project 2021-06) (ARDL, Inc.)

- o GW-23B & GW-23C Gravity Drains at RAPS
 - Partially completed the week of 01 May.
 - The 36-inch pipe that originally exited GW-23 was "abandoned" in the late 70's or early 80's by the refinery. It turns out this pipe was only partially abandoned. While attempting to dewater this pipe, water was seeping back from the river. More discussions necessary on this issue.
 - Inspection of GW-23 next week (weather dependent).

• Relief Well Testing / Inspection (Project 2022-07) (ARDL, Inc.)

o FY'23 Scope (19 Relief Wells in UWR). Q4 FY'23.

• EA1 Pump Station Pump No. 2 Rebuild (Project 2022-09) (The Pump Shop at Missouri Machinery & Engineering, Co.)
